- 1. Use the data in the Excel file **154quiz12data.xlsx** to construct a scatterplot that predicts selling price from appraisal value. Be sure to label the graph appropriately. Find the linear regression equation, correlation value (r) and coefficient of determination  $(R^2)$ . Use this information to answer the questions that follow.
  - a. Write your regression equation.
  - b. Interpret the slope of the equation in context.
  - c. If possible, interpret the y-intercept. If it cannot be interpreted in context, explain why not.
  - d. What is the correlation? Is this a strong, moderate or weak correlation? Is it positive or negative?
  - e. What is the  $R^2$  value?
  - f. Interpret the coefficient of determination in the context of the problem.
  - g. Use the equation to predict the selling price of a house appraised for \$180,000 if the trend continues.
